VIRTUAL 10th NATIONAL NUTRITION CLUSTER MEETING Via ZOOM LINK KATHMANDU, NEPAL

FRIDAY, 12 JESTHA 2077 (22 MAY 2020)

The nutrition cluster was officially activated, led by the Family Welfare Division (FWD) of Department of Health Services (DoHS) of Ministry of Health and Population (MoHP) to initiate nutrition preparedness and response Actions to address nutrition issues in existing Covid-19 targeting under five years children, pregnant and lactating women and elderly (60 years plus) population. This is the tenth meeting after activating the nutrition cluster. The meeting was chaired by Nutrition Cluster lead Mr. Kedar Raj Parajuli, Chief of Nutrition Section of FWD/DoHS/MoHP and co-chaired by the cluster co-lead Mr. Anirudra Sharma, Nutrition Specialist, UNICEF. Altogether 136 plus people from different organizations were invited out of which 87 attended via zoom link.

- Lalbandi Municipality distributed 2 Kg Chana, 60 IFA tabs and Dettol soaps to 1,490 Pregnant mothers
- Supported to organize the District Level H&N cluster meeting in Sarlahi district
- Supported to collect the data of HHs of G1000D days mothers at Parsauni Gaupalika, Bara and Parsagadhi NP of Parsa for the relief distribution
- Thori Gaupalika of Parsa district distributed relief package to G1000 days mothers (Mask, sanitizer, eggs and food items)
- Aasman Nepal with support from WHH has been providing following support in the following districts:
- Soap distribution is ongoing by door to door in Saptari and Rautahat for mothers' of G1000 days covering 3,600 HHs
- Breastfeeding and complementary feeding counselling is provided by using flip chart through home visit

- Messages for the prevention of COVID-19 are given
 - With UNICEF's support, ongoing airing of the messages of nutrition in the context of COVID-19 through 32 FMs of province # 2. Similarly, ongoing the talk program (COVID KURA) on nutrition has been ongoing with experts through FM radio to disseminate nutrition the messages.

Bagmati province:

Mr. Shambhu Kafle, Public Health Administrator of Provincial Health Directorate (PHD) briefed following points:

- Ongoing follow up with Health Facilities to ensure availability of Health & Nutrition services and commodities and COVID Prevention Group (CPG) formation and activation.
- This week Suaahara Technical officers followed up 21 HFs and reported 3 HFs are stock out (Vit A, RUTF MNP) and COVID Prevention Groups are not formed in 13 HFs.
- Ongoing phone counselling to 3,776 pregnant and 16,159 lactating women by Suaahara staffs on Health and Nutrition and considering to COVID-19. Total 68,472 HH reached with nutrition and Covid-19 awareness messages. During phone counseling a total of 18,204 HHs have been assessed on food availability and based on this 2,187 HHs are referred for Food Aid program of local government.
- Suaahara continuously supporting to air nutrition related Radio program Bhanchhin Ama, COVID prevention related Hello Bhanchhin Ama and different PSAs for the promotion of Nutrition through 13 FMs and Radio Nepal.
- Suaahara staffs are follow up and counseling MAM and SAM cases as well in Five working districts.

Gandaki Province:

On behalf of Gandaki Province, Mr. Nawaraj Sharma, the health education and communication officer of Provincial health Directorate briefed the following points:

- Established H&N cluster and first meeting was accomplished on 15 May 2020.
- Develop province wide Vitamin A supplementation plan and propose in the next cluster meeting
- Develop nutrition supply plan for the province
- Develop Covid-19 response plan for the province

- Received 12 Cartoons MNP and 2 Cartoons F75 from Province

- Suaahara Program has been conducting Risk Communication and community engagement to raise awareness on nutrition and COVID-19. In between Since 08 April to 19 May 2020, altogether 80,404 Households were reached by telephone counseling. Out of them, 22,667 were 1000 days' HHs. Similarly, 1,572 households were referred to local governments for food relief & 177 people were referred to local health facilities those have health problem. Besides that, 16 local FMs stations have been regularly broadcasting 15 PSAs focusing on emergency nutrition and COVID-19 on daily basis. Likewise, Bhanchhin Aama Raido weekly episodes also airing focusing on maternal and child nutrition.
- Circulated the interim guidelines on MIYCN and IMAM to the local levels.

- Develop Monsoon response plan considering Covid-19 situation
- Continue nutrition service monitoring
- Facilitate to continue all nutrition rehabilitation homes

Province number 5:

On behalf of Provincial Health directorate, Ms. Huma Kumari Pun, Senior Health Administrator briefed the following points:

- Health and nutrition cluster already established, and TOR

 Nutrition Cluster meeting was held on 18 May 2020 with action
 plans to take forward the cluster activities.
- Cluster in coordination with Health Offices, isolation hospitals, and quarantine centers is identifying PLWs, children under-five and guiding them to ensure screening for nutrition status, provision of nutrition services (IFA to PLWs, Vitamin A, MNP, and Deworming to the children and necessary management of MAM/SAM if identified).
- Field level staff of MSNP, Suaahara and ACF are mobilized to track the SAM cases and screening at HF level. 7 new cases (1 in Rukum Eat, 3 in Banke, 2 Rupandehi, and 1 Dang) are enrolled in OTCs. 17 defaulters (7 in Banke, 5 Rupandehi, and 5 in Dang) were followed and among them 1 in Dang was re-enrolled in OTC.
- Province Health Logistic Management Center (PHLMC) with transport support from UNICEF and in coordination with Suaahara sent MNP (12 cartons), F75 (2 Cartons), and F100 (6 Cartons) to PHLMC of Gandaki Province.
- Suaahara and ACF is providing nutrition counseling for MIYCN and conducting follow-up of SAM children via phone communication. With support from Suaahara, COVID RC messages are being aired from more than 100 FM Radio stations. Interview of Honorable Chief Minister was aired last week.

 health workers, FCHVs and field staff in cooperation with
 federal, provincial and local governments.
- Save the Children supporting 12 Palikas in programme districts aimed at improving RMNCHN and IEC materials on COVID – 19, nutrition messaging through radio in Jajarkot and Kalikot

- Facilitate to continue all nutrition rehabilitation homes
- Develop specific strategy to provide screening services to the children 6-59 months and ensure provision of SAM treatment considering Covid-19 context

Sudur Paschim province:

Dr Bhusan Mishra and Mr Min raj joshi of Provincial Health Directorate of Sudurpaschim Province briefed the following points:

- Health and Nutrition cluster formed, and functional and ongoing bi-weekly meeting regularly.
- With the support from UNICEF and SUAAHARA, ongoing commodities stock tracking and functionality assessment of OTCs and NRHs is been carried out.
- Out of three NRH is Sudur Paschim province, one NRH (Dhangadhi) has been operated and 4 children are admitted for treatment. Ongoing discussion with Hospital management to activate remaining 2 NRH.
- With the support from UNICEF and SUAAHARA, nutrition BCC messages are been aired regularly from different 42 Local FMs (19 from UNICEF and 23 from SUAAHARA in 3 languages-Nepali, Tharu and Doteli) in the province covering all districts. Approx. 40% people are reached through the nutrition messages.

- Provincial level nutrition and food security steering committee meeting was organized and discussed on how can be given priority to nutrition program in the upcoming fiscal year.
- MoEAGA has issued a letter to all provincial ministries and local government regarding incorporation of MSNP interventions/activities in upcoming annual budget and planning.
- This week total 25,908 (Total 1,42,522HHs) Households counselled by Suaahara front line worker, send pushed massages to HHs, interviewed with experts and massaging thorough social media about COVID-19 and Nutrition promotion.
- This week 52 Health Facility (Total 328HFs) were counselled by Suaahara technical officers for reviving the services, and identified the stockout of Nutrition and essential commodities,

Information Management (MN) TWG: Ms. Manisha Shrestha, member of IM TWG explained the following points in nutrition cluster: Ongoing collection of information of nutrition services. Out of 20 districts, the information was collected from 10 districts. The information from remaining 10 districts will be collected within a week and compiled and disseminated. Updated Nutrition 3W mapping-General for the nutrition intervention Updated bi-weekly Covid-19 response tracking sheet First phase of data collection is completed. There is data from only 10 districts. Partner are continuing the data collection in the remaining districts and health facilities. First phase of data collection was share in the cluster meeting. Micro-nutrient (MN) TWG: Mr. Naveen paudel, the Chair of MN TWG briefed that MN TWG has presented the outcomes of MN TWG discussed on the Vitamin A supplementation which was postponed by MoHP until further notice. Major points were as follows: It is necessary to identify alternate strategy for mass supplementation of postponed vitamin -A campaign along with de-worming tablet distribution combined with MNP distribution and MUAC measurement, if feasible. Since Vitamin A capsules have not arrived yet in the country, it is necessary to advocate with the government to get them at the earliest possible. Developed concept note on VAS distribution using three service contact points: (1) Health facility (2) FCHVs/ Parents and Caretakers, and (3) Outreach Clinic (ORC) Discussed cons and pros of Health Facility, FCHV/ Parents and Caretakers and ORC as service point. Developed draft VAS guideline using health facility as point of Vitamin 'A' capsule distribution. IMAM TWG

- Blanket supplementary feeding (BSF) should be prioritized (with adequate funding from the government and partners) to prevent acute malnutrition in the context of protracted lockdown, higher GAM rates (especially in Terai region) and increasing HH food insecurity during the lean season.
 Preventive measures should also be aligned / coordinated with other sectors like WASH, food security etc.
- Additional strategies for screening of children for acute malnutrition should be explored beside EPI clinics, family/mother MUAC e.g. combining with MCHN follow up, targeted mobile services for screening from partners mobilizing FCHVs and HWs etc.
- Advocacy with local authorities (DAO, Palikas etc.) should be continued by partners and / through HOs for easy access of beneficiaries to health facilities / treatment Centres during the lock down.
- Procurement and distribution / transportation of nutrition commodities for IMAM services should be prioritized.

- Develop interim guidance note for Supplementary feeding (blanket and targeted)
- Develop mechanism to initiate Family/ Mother MUAC (videos, supply chain of MUAC tapes, global guidance etc.) along with other alternatives such as; EPI clinics, MCHN, targeted mobile services from partners mobilizing FCHVs and HWs etc.
- Develop IPC measures for NRH (status, challenges, assessment etc.) – some alternative modality
- Consider a strategy for weekly phone follow up and implementation.

BCC TWG:

On behalf of BCC TWG Mr. Kunj Joshi, the Chair of BCC TWG from NHEICC briefed as follows:

- SMS in local language related breastfeeding in COVID-19 for pregnant and lactating women sent out in 42 districts
- Breastfeeding radio PSA airing from FM stations in Karnali and Sudur Paschim province
- # episodes di "Hello Banchin Amaa" Radio programme covered nutrition issues linked with COVID-19.
- Half an hour radio interview with "Avenues" television on importance of breastfeeding, infant and young child feeding
- NHEICC with support from UNICEF and Suahaara will air breastfeeding related PSA from Nepal television and different FM stations from 26 May 2020
- Dedicated radio programme discussing breastfeeding on Corona Care "Nepal Television and "Hello Banchin Amaa", Corona Capsule- Radio programme
- Media landscape survey showed 67% people are getting information from television, 53% from the radio and around 30% from social media (social media reach is in Bagmati and Gandaki province)
- Reach and recall survey gives the information source but will be difficult to assess the effectiveness of each sectoral messages so need to build on the data collection mechanism that is used from another group
- Nutrition related BCC messages currently being monitored at different levels by central, provincial and district teams
- Analysis of audio-visual aids developed from the provinces:
 - Difficult to assess the quality and numbers of materials produced or developed by the provincial level. Many of the materials will not come to the BCC group for review. With the decentralized structure its difficult to request for quality control.
 - Not any PSAs related to nutrition received yet from the provinces.

- Coordinate with IYCF and provincial nutrition clusters to review and standardize IYCF and other nutrition messages as well as audio visual aid across the provinces.
- Develop monitoring mechanism to monitor the messages disseminated through different media such as; FM radios, TV and others.
- Identify coverage status of nutrition messages whether nutrition messages cover throughout the country or not.
- Integrate and broadcast/disseminate nutrition messages in Corona capsules and Corona care programme broadcasting through FM radio and TV
- Organize a virtual interaction programme/conference with journalist from reputed national medias on IYCF and Breast Milk Substitute Act (1992) under leadership of FWD & NHIECC.
- Identify the contract numbers of FCHVs and develop mechanism to orient them on IYCF and other nutrition related topics

Remarks from Ms. Laxmi Ghimire, Under Secretary, the National Planning Commission (NPC)

Ms. Laxmi Ghimire, Under Secretary of NPC during her remarks highlighted the following points:

- She was very happy by hearing the progress made by provincial nutrition clusters and nutrition cluster TWG. Very good progress has been made throughout the country.
- In order to see the socio-economic impacts of the Corona-19 in Nepal including global lesson learned, NPC formed a committee where Prof. Fr. Geeta Bhakta Joshi, former member of NPC is also a member of that committee.

Remarks from Professor Dr. Madhu Dixit Devkota:

Professor Dr. Madhu Dixit Devkota, technical expert on nutrition and member of High-Level Nutrition and Food Security Steering Committee, in her short remarks highlighted the following points:

- Thanked to all organizers and participants of the cluster meeting
- The stigma against Corona-19 infected people need to me addressed. It is also needed to communicate to MoHP to address this issue also.
- The term "Sealed" using for the areas of Corona-19 positive cases is not appropriate. It would be appreciated if MoHP replace this term with other appropriate term also.
- During this Covid-19 pandemic and lock down situation, wasting among the small children can be increased and wasted children are at more risk of morbidity and mortality. Therefore, more attention should be given on this matter. This is also because of potential disruptions of the nutrition services and undernutrition makes them more susceptible to infection. Therefore, attention is required as earliest as possible

Closing of the meeting and next nutrition cluster meeting

Mr. Anirudra Sharma, the nutrition cluster co-lead and meeting facilitators thanked to the meeting Chair for his leadership and coordination and to all participants for their active participation and highlighted the following agreed action points from the meeting:

- Supplementation of Vitamin A capsules is a priority for all of us therefore, it was requested to all provinces to come up with the implementation plan in the next cluster meeting.
- Identify alternative mode of screening in all areas to find acute malnutrition and their management.
- Federal nutrition cluster will be working on supplementary feeding programme also.
- It is also necessary to finalize nutrition cluster TOR for all provinces and preparation and finalization of Monsoon as well as Covid-19 response plan for provinces.

With this, Mr. Anirudra Sharma requested to <u>Mr. Kedar Raj Parajuli, Chief of Nutrition section of FWD and Federal level nutrition cluster lead</u> to close the meeting with his remarks. During the remarks, Mr. Parajuli highlighted the following points:

- He thanked to all participants including provincial health Directors and other representatives from NPC, MOFAGA, all cluster members from federal and provincial nutrition cluster as well as other invitees;
- He also focused to implement Vitamin A supplementation in all provinces and requested to all provincial health directorate to come up with the specific plan in the next cluster meeting

- He also highlighter BCC TWG to work on the leaflets on nutrition BCC message and send to all provinces. Before
 that, he also requested to all provinces to send the BCC materials to the BCC TWG as earliest as possible to make
 standardize the message.
- Requested IMAM TWG to prepare supplementary feeding guidance note in leadership of WFP and submit in the next nutrition cluster meeting.
- Nutrition commodities, wherever is gaps will be fulfilled soon. However, some commodities are required to province 3 as soon as possible.
- MUAC tape if available, we should provide to all provinces.
- He closed the meeting by announcing the next nutrition cluster meeting to be held on **Friday**, **16 Jestha 2077** (29 May 2020) from 11:00 to 13:00 hrs. via zoom link.

- Ongoing counselling of mothers/caregivers on IYCF and maternal nutrition including awareness on COVID-19 through mobile phone focusing to G1000D households in different districts.

- Apart from health workers, MSNP coordinators, MSNP volunteers, staff members from Suahaara programme, Staff members, ACF other CSOs are also working at palika levels and coordinating local governments and health facilities to continue nutrition services.
- Supported nutrition commodities in the areas of measles outbreak as; (i) **Dhading district:** supported 8,000 capsule of Vitamin A, 480 box (2 Cartoon) of MNP, MUAC tape 45 pieces of MUAC tape and 6,000 tablets of Albendazole to Gajuri and Benighat Rorang Rural Municipalities During immunization, 6-59 months children were screened and 25 SAM children are identified. FWD already asked to central Medical Store, Pathalaya to transport 30 cartons of RUTF to Dhading district to treat these SAM children; **(ii) Gorkha district:** There was also a measles outbreak in Gandaki Rural

Municipality and Sahid Lakhan Thapa Rural Municipality of Gorkha district. FWD supported 7000 capsule of Vitamin A and 20 pieces of MUAC Tapes.
