मिति २०८० कात्तिक १७ गते कर्णाली प्रदेश जाजरकोट जिल्ला केन्द्र विन्दु भएर गएको भूकम्प र पराकम्पहरुबाट भएको क्षति सम्बन्धमा Early Recovery Cluster सदस्य र CBDRM Platform सदस्यहरुको संयुक्त बैठकमा निम्नानुसार छलफल तथा निर्णय गरियो ।

- जाजरकोट जिल्ला केन्द्र विन्दु भएर गएको भूकम्प र पराकम्पहरुबाट भएको क्षतिको हालसम्मको प्रारम्भिक विवरण तथा राहत र उद्धारमा भईरहेका प्रयत्नहरुको बारेमा गृह मन्त्रालय तथा नेपाल रेडक्रस सोसाइटीबाट जानकारी प्राप्त भयो ।
- विपद् प्रभावित सम्पूर्ण परिवारलाई शीघ्र सामाजिक आर्थिक पुर्नलाभका कार्यक्रममा समेट्न रोजगारी गुमाएका परिवार/व्यक्तिहरुलाई रोजगारी सृजना गर्न, पशुपालन व्यवसाय, कृषि व्यवसाय, साना, घरेलु तथा लघु उद्यम व्यवसाय, स्थानीय पूर्वाधारहरुमा (खानेपानी, विद्यालय, सिंचाई, सडक, बाटो संजाल लगायत पूर्वाधार) सहयोग गर्ने कार्यक्रमहरु संचालन गर्ने ।
- अन्तराष्ट्रिय विकास साझेदार तथा नेपाल रेडक्रस सोसाइटी लगायत यस क्षेत्रमा क्रियाशील सामाजिक संघ संस्थाहरुको अन्य क्षेत्रमा रहेको स्रोतलाई पुनर्लाभको क्षेत्रमा परिचालन गर्न अनुरोध गर्ने सो काम गर्दा स्रोतको एकीकृत परिचालन गर्ने, दोहोरोपना हटाई एकरूपता कायम गर्ने ।
- भूकम्प प्रभावित घर परिवारको क्षति/हराएका व्यक्तिगत कागजातहरुको संकलन र संरक्षण गर्न आवश्यक सहजीकरणको लागि पालिकास्तरमा स्वयंम सेवकहरु परिचालन गर्ने ।
- जाजरकोट जिल्ला केन्द्र विन्दु भएर गएको भूकम्प र पराकम्पहरुबाट प्रभावित भएका अति विपन्न परिवारहरुको न्यूनतम जीवनयापनका लागि आवश्यक पर्ने एक महिनाको खाद्यान्न बराबरको नगद सहायता जिल्ला विपद् व्यवस्थापन समितिको सिफारिस तथा स्थानीय विपद् व्यवस्थापन समितिको प्रत्यक्ष समन्वय तथा नियमनमा एकद्वार प्रणाली मार्फत परिचालन गर्ने ।
- Early Recovery चरणमा गर्नुपर्ने सुरक्षा, स्वास्थ्य तथा सरसफाई, मनोपरामर्श सम्बन्धी सचेतना/नागरिक शिक्षा सम्बन्धी कार्यहरुमा विशेष जोड दिने ।
- भूकम्पबाट क्षति भएका निजी आवासहरुको भग्नावशेषहरुको सरसफाई, मृत पशुपंक्षीको उचित व्यवस्थापन गर्न स्वयंम सेवकहरु परिचालन गर्ने ।
- विपद् प्रभावित परिवारलाई शीघ्र पुर्नलाभका कार्यक्रम सञ्चालन गर्दा तीनतह सरकारको बीचमा कुनै समन्वय तथा सहजीकरण गर्न आवश्यक भएमा सोको समन्वय संघीय मामिला तथा सामान्य प्रशासन मन्त्रालयले गर्ने ।
- भूकम्प प्रभावित क्षेत्रमा संचालन हुने शीघ्र पुर्नलाभ कृयाकलापमा विपद् जोखिम न्यूनिकरण तथा पूर्वतयारीका कृयाकलापहरुलाई समेत आवद्ध गरी कार्यक्रम संचालन गर्ने ।
